2017年第二季營運成果摘要

▶ 第二季營收為 NT\$12.44億元,較去年同期增加24.4%。

▶ 第二季毛利率為 23.4%,較去年同期減少 4.0個百分點。不包含光耀 及光峰的本業毛利率為29.1%,較去年同期增加0.7個百分點。

▶ 第二季營業利益率為 7.1%,較去年同期減少 0.9個百分點。

▶ 第二季淨利為 NT\$ 34百萬元, EPS為NT\$0.25元,較去年同期增加 19%。


▶ 2017年第二季營收大幅成長主因本業全像營收增加 , 及轉投資公司光耀的營收成長。

註:其他包含金蔥粉、裝飾性產品、材料等






2Q17 營業毛利及毛利率

- ▶ 光群第二季營業毛利率降低,主要受光耀影響。
- ▶ 第二季本業毛利率 (含和銳)與去年同期相較,提升0.7百分點至29.1%,主要係來自於加強製程控管以提升生產效率及良率,以及無版縫產品(TSL)占比增加,所帶來降低成本的效益。



TSL 營收佔比










2Q17 營業利益




2Q17 淨利與每股盈餘










